Dear Constituent.

Since the last newsletter, debate in the House of Commons has ranged from labour legislation, changes to the *Competition Act*, improving transparency to federal transportation and more. This flurry of activity included the fall economic statement, which serves as a fiscal snapshot with an accompanying act for implementation (C-59) that is still being debated. As for what I've been hearing from constituents - affordability and the rising cost of living remain top of mind with the holidays approaching.

This past November, in the House of Commons, I had the opportunity to speak a number of times on the importance of Arctic sovereignty in Canada's North during a concurrence motion. You can watch my interjections here: https://youtu.be/9NwI-LxQ18c?si=kEvHo3zvtoaKmhJ6.

In mid-November, a group of constituents approached me and asked that I support <u>Motion-86, Citizens'</u>
<u>Assembly on Electoral Reform</u>, a non-binding Private Member's Motion which will be up for a second reading vote in February. I am taking this opportunity to consult with constituents about whether a Citizens' Assembly on Electoral Reform is something they would like to see. MOTION TEXT - That:

- (a) the House recognize that,
- (i) representative democracy is a fundamental part of Canadian society,
- (ii) in Canada's current electoral system, the majority of voters cast ballots for a candidate who does not get elected, and many voters feel that election results do not accurately reflect their views,
- (iii) a Leger poll conducted in September 2020 showed that 80% of Canadians support the idea of striking a non-partisan, independent citizens' assembly on electoral reform,
- (iv) many Canadians are concerned with the health of Canada's democracy, including voter distrust and disengagement, low voter turnout, and the polarization of politics,
- (v) all politicians, and all parties, are widely perceived by the public to have a vested interest in the design of the electoral system,
- (vi) citizens' assemblies have considerable legitimacy and public trust because they are independent, non-partisan, representative bodies of citizens,
- (vii) citizens' assemblies have been used successfully in Canada, Australia, Belgium, France, Ireland, Scotland, the Netherlands, and the United Kingdom to tackle difficult issues through nuanced public deliberation, (viii) a citizens' assembly on electoral reform would give citizens a leadership role in building consensus on a
- specific model for electoral reform for Canada; and (b) in the opinion of the House, the government should create a Canadian citizens' assembly on electoral reform, which would,

(i) consist of citizens selected by sortition, an impartial selection process to ensure the assembly's independence and non-partisanship,

(ii) reflect the diversity of the Canadian population, including a representation and meaningful participation of age groups, genders, ethnicities, languages, socioeconomic backgrounds, and geographic regions including from First Nations, Inuit and Metis peoples,

(iii) determine if electoral reform is recommended for Canada, and, if so, recommend specific measures that would foster a healthier democracy.

At the end of November, the Liberal government finally went live with a 9-8-8 suicide hotline. My conservative colleague, MP Todd Doherty, has been advocating for the creation of a national suicide hotline in Canada for years, and it is great to see this initiative come to fruition. On November 24, 2023, the government announced the launch of a public consultation on legislative amendments to counter foreign interference. The government published two consultation papers:

- Addressing foreign interference (justice.gc.ca): Whether to amend the Security of Information Act and modernize certain Criminal Code offences, and to introduce a review mechanism in the Canada Evidence Act to manage sensitive information
- Enhancing measures to counter foreign interference: Whether to amend the Canadian Security Intelligence Service Act (publicsafety.gc.ca)

This public consultation closes on February 2, 2023.

In addition, the government published "What We Heard Report: Consulting Canadians on the merits of a Foreign Influence Transparency Registry."

With respect to seniors, I missed highlighting in last month's newsletter the vote on MP Larouche's bill C-319:

This enactment amends the Old Age Security Act to increase the amount of the full pension to which all pensioners aged 65 or older are entitled by 10% and to raise the exemption for a person's employment income or self-employed earnings that is taken into account in determining the amount of the guaranteed income supplement from \$5,000 to \$6,500.

This bill passed second reading and was sent to committee for study despite all Liberal MPs voting against it. In addition, I want to remind all seniors with internet access to check out the Government of Canada website regularly for the latest updates on any federal programs and benefits: www.canada.ca/seniors.


