With the Liberals and NDP engaging in a supply and confidence agreement, it has been much more difficult for opposition MPs like myself to impact and improve the Liberal government's legislation.

On May 20<sup>th</sup>, I asked the finance minister why Canada charges an excise duty on wineries and cideries as they struggle to bounce back from the COVID-19 pandemic. This past May on the Special Committee on Afghanistan (AFGH) we continued our study on the situation in Afghanistan in order to complete our June 8<sup>th</sup> report. We heard from many witnesses including: the Minister of Foreign Affairs, the Minister of National Defence, and former Afghan interpreters.

Despite being moved from the Standing Committee on Human Resources, Skills and Social Development and the Status of Persons with Disabilities (HUMA) to the National Security and Intelligence Committee of Parliamentarians (NSICOP) at the end of May, I am proud of the important work I was able to contribute to in improving government legislation and address key issues while on the HUMA committee. Our focus areas this past May included: the impact of COVID-19 on seniors, labour shortages, working condition, and the care economy, the Housing Accelerator Fund, and certain divisions of Bill C-19 (the Budget Implementation Act). It was an honour to serve

on the HUMA committee as some of the most pertinent and impactful legislation was put forward and amended there.



## Age Well at Home

This grant program offers funding to organizations/projects that help seniors stay in their homes longer. There are two application streams:

In-Home Support Pilot Projects which funds organizations that offer eligible volunteer-based services to seniors. Eligible services could include meal preparation or delivery, light yard work, snow removal and home visits. <a href="https://www.canada.ca/en/employment-social-development/services/funding/seniors-age-well-at-home-in-home-support.html">https://www.canada.ca/en/employment-social-development/services/funding/seniors-age-well-at-home-in-home-support.html</a>. Organizations can receive up to \$800,000 in funding; and,

Organizations can receive up to \$2 million in funding.

#### Canada Greener Homes Loan

Complete major retrofits to your home through an interest-free loan of up to \$40,000. Before you get started:

- You need to be approved for the grant before applying for the loan. Only homeowners who
  are eligible for the Canada Greener Homes Grant can apply for the Canada Greener Homes
  Loan.
- You must have a pre-retrofit evaluation done and have your renovation upgrade report.
- You must be approved for the loan before you start your retrofits. You cannot apply for any retrofits you have already commenced.
