Dear Constituent,

I hope that you are enjoying your summer and taking time to explore and take in the beautiful scenes right here in Bruce-Grey-Owen Sound. Over the summer, I have had the opportunity to meet with hundreds of constituents at local celebrations, events and meetings, gathering feedback for the upcoming fall session in Parliament.

Alongside community engagement, my Conservative colleagues and I have been working hard on the policy front-most recently by pushing for much-needed bail reform. Led by former Crown prosecutor and Conservative Shadow Minister for Justice and Attorney General of Canada, MP Larry Brock, Conservatives are calling on the Liberal government to:

- 1. Amend Canada's Criminal Code to make bail more restrictive for repeat violent offenders, particularly those charged with firearms offences, intimate partner violence, and serious violent crimes;
- 2. Repeal Bill C-5 which eliminated mandatory minimum sentences for serious violent crimes;
- 3. Repeal the so-called principle of restraint enacted by Bill C-75 which requires judges to release accused offenders "at the earliest possible opportunity" under the "least onerous conditions";
- 4. Support law enforcement and victims' rights advocates by ensuring the justice system puts public safety first and provides real consequences for violent repeat offenders;
- 5. Work with provinces, territories, and Indigenous communities to ensure consistent and effective bail policies that protect all Canadians regardless of jurisdiction.





### Enabling Accessibility Fund - Youth Innovation Component

The Enabling Accessibility Fund (EAF) is looking for dynamic youth who want to demonstrate leadership and a commitment to their communities. Through this process, youth volunteer their time to build a more accessible Canada.

#### Application period:

May 30, 2025, to October 6, 2025, at 3:00 pm Eastern Daylight Time (EDT)

#### Who can apply:

## New Horizons for Seniors Program - Community-based projects (up to \$25,000)

Funding amount: Up to \$25,000

Application period: Open August 6, 2025 to September 17, 2025 at 3:00 pm, Eastern Daylight Time (EDT)

Who can apply: Eligible organizations can apply for up to \$25,000 for projects that are led by seniors and are volunteer based.

What this program offers: The New Horizons for Seniors Program (NHSP) community-based stream is a federal grant. It supports projects that are designed by seniors and for seniors in their communities. This program funds projects that empower seniors in their communities through increased social inclusion.

### Canada Disability Benefit

The Canada Disability Benefit will be a monthly payment for low-income working-age persons with disabilities.

The first month of eligibility is June 2025 and it is expected that payments will begin in July 2025. The maximum amount of the Canada Disability Benefit will be \$200 per month, or \$2,400 annually (July to June). The amount someone receives will depend on their income and the income of their spouse or common-law partner.

Eligibility Requirements — To receive the benefit, a person must:

- 1. Be a resident of Canada for the purposes of the *Income tax Act* determine your residency status;
- 2. Have been approved for the Disability Tax Credit <a href="https://www.canada.ca/en/revenue-agency/services/tax/individuals/segments/tax-credits-deductions-persons-disability-tax-credit.html">https://www.canada.ca/en/revenue-agency/services/tax/individuals/segments/tax-credits-deductions-persons-disability-tax-credit.html</a>;
- 3. Be between the ages of 18 and 64; and
- 4. Have filed an income tax return with the Canada Revenue Agency for the previous tax year.

  For example, to receive benefits for the July 2025 to June 2026 payment period, the person must have filed a return for the 2024 tax year.

The renewal process for the 2025 to 2026 benefit coverage period has ended. If you haven't renewed and your CDCP coverage ended on June 30, 2025, you can <u>submit a new application</u>.
