Dear Constituent,

I hope that everyone was able to enjoy time with their loved ones this Thanksgiving. Since the last newsletter, the House of Commons has resumed its proceedings in Ottawa. There have been many issues to debate on your behalf from affordability, to justice reform as a result of rising crime rates in Canada over the last decade, to support for our veterans and much more. I've proudly jointly seconded seven Private Members' Bills from my Conservative colleagues. These bills all put forward solid proposals to address crime, transparency and protection of natural health products.

Alex Ruff has indicated formal support by jointly seconding the following private members' bills sponsored by other members.

Bill #	Title
C-246	An Act to amend the Criminal Code (consecutive sentences for sexual offences)
C-242	Jail Not Bail Act
<u>C-240</u>	Offender Rehabilitation Act
<u>C-230</u>	An Act to amend the Financial Administration Act and to make consequential amendments to other Acts (debt forgiveness registry)
<u>C-225</u>	An Act to amend the Criminal Code
C-224	An Act to amend the Food and Drugs Act (natural health products)
<u>C-221</u>	An Act to amend the Corrections and Conditional Release Act (disclosure of information to victims)

Although not debated, the Liberal Government is moving forward with their Firearms Confiscation Program via regulation not legislation. This program will impact thousands of law-abiding, vetted and trained firearms owners. The Liberal firearms confiscation program is officially described as voluntary; however, it's important to note that individuals who own any of these now prohibited firearms must either turn them in or have them permanently deactivated before the end of the amnesty period, or risk criminal liability for illegal possession. The Government has launched a pilot phase of its compensation program in Cape Breton, Nova Scotia and plan to roll out the program nationwide later this fall. According to the Liberals the program will cost approximately \$750 million (independent expert analysis have projected the cost could reach \$1.8 billion dollars), in total. The Liberal Government is costing Canadians billions of dollars and are unfairly targeting law-abiding legal gun owners. Experts project that this program will have minimal impact on violent crime.

On September 26th, I had the opportunity to ask the Liberal Government why they are focused on punishing the most statistically law-abiding demographic of Canadians: legal gun owners. You can watch the two questions I asked here: https://www.youtube.com/watch?v=1FpSZak8g00. I reminded the Liberal Ministers that assault rifles have been

banned in Canada since January 1978. After reminding the government of this fact, the Liberal House Leader had the audacity to respond that hunters don't need a sub-machine gun to hunt a deer. Of course they don't. Sub-machine guns have been banned in Canada since 1978!

The Liberal Government had planned to implement a maximum two-wreath per riding funded by Veterans Affairs Canada for this upcoming Remembrance Day, on the 80th Anniversary of the end of World War Two. Pushback by many of my Conservative colleagues publicly and my opportunity to raise this issue during Question Period on October 3rd saw the Liberal Minister of Veterans Affairs back down and reverse her decision. Personally, I believe at a minimum our government should be providing a wreath at every cenotaph in Canada in remembrance of the over 100,000 Canadians that have made the supreme sacrifice. Over the Thanksgiving weekend, I had the opportunity to represent Canada as part of the all-party parliamentarian delegation to the NATO Parliamentary Assembly in Slovenia. You can review the conclusions we reached here - https://www.nato-pa.int/content/annual-session-ljubljana-2025-conclusions.

On October 15th, I had the opportunity to join MPP Paul Vickers and members of the Owen Sound & District Chamber of Commerce for a focused discussion on the issues impacting our region. We tackled key topics including housing affordability, labour shortages, red tape, and the pressures small businesses are facing in today's economic climate. I listened carefully to the concerns and shared updates on federal initiatives aimed at supporting rural communities like Bruce-Grey-Owen Sound. My commitment remains clear: to represent our region with integrity, push for practical solutions, and ensure your voices are heard in Ottawa. I appreciate the Chamber's leadership in bringing people together and creating space for meaningful conversations in our community.

As well, I'd like to share the feedback from my Spring 2025 Update mailout. The people of Bruce-Grey-Owen Sound identified their top federal priorities for Parliament as follows: cost of living and affordability (30.6%), housing (23.9%), economic development (22.8%), crime and justice reform (13.4%), and trade/tariffs (12.3%).

Regarding the question on a national energy corridor to transport Canada's natural resources to global markets, strong support was expressed, with 84.85% of respondents in favour, 4.71% opposed, and 10.44% unsure.







Regional Tariff Response Initiative in southern Ontario

The Government of Canada is helping Canadian businesses respond to global trade pressures. Funding per recipient

Businesses can normally request:

- \$125,000 to \$10 million in repayable funding; or
- \$125,000 to \$1 million in non-repayable funding.

Not-for-profit organizations can normally request a minimum of \$125,000 to \$10 million in non-repayable funding. Eligible applicants

- Incorporated for-profit businesses located and operating in southern Ontario employing at least 5 full-time equivalent employees in the region and fewer than 500 full-time equivalent employees overall.
- Not-for-profit organizations in southern Ontario whose primary focus is to support SMEs.

Canada Disability Benefit

The Canada Disability Benefit will be a monthly payment for low-income working-age persons with disabilities.

The first month of eligibility is June 2025 and it is expected that payments will begin in July 2025. Further information regarding the benefit can be found here: https://www.canada.ca/en/services/benefits/disability/canada-disability-benefit.html.

The maximum amount of the Canada Disability Benefit will be \$200 per month, or \$2,400 annually (July to June). The amount someone receives will depend on their income and the income of their spouse or common-law partner.

Eligibility Requirements — To receive the benefit, a person must:

- 1. Be a resident of Canada for the purposes of the *Income tax Act* determine your residency status;
- 2. Have been approved for the Disability Tax Credit https://www.canada.ca/en/revenue-agency/services/tax/individuals/segments/tax-credits-deductions-persons-disability-tax-credit.html;
- 3. Be between the ages of 18 and 64; and
- 4. Have filed an income tax return with the Canada Revenue Agency for the previous tax year.

 For example, to receive benefits for the July 2025 to June 2026 payment period, the person must have filed a return for the 2024 tax year.

Applications are open. Eligible Canadians of all ages can now apply for the CDCP.

Renewal period
